- **Pregnant women who get the Tdap vaccine:** IKC educational module in development for OB/GYNs and pregnant women on getting Tdap and Flu vaccine during pregnancy
- Reduce proportion of children who get no recommended vaccines by age 2 years: Data?
- Maintain MMR vaccination coverage for children

  - ii. State level data for combined birth years; most recent available is 2016-2017
  - iii. Kansas: 77.8% (+/- 5.1%)

- Increase proportion of people with vaccination records in an information system: Kansas WebIZ mandate in effect July 2020
- Increase proportion of adults age 19yrs+ who get recommended vaccines
